In response to the results of a survey distributed by AHME's Council on Professional and Faculty Development, this webinar will address the important topic of health care disparities. Dr. Baretta Casey, ACGME Regional Vice President, CLER Site Visit Program, will describe the development of this area of attention within CLER, and two leaders in AHME member institutions will share initiatives of their organizations. - Identify at least one strategy or next step the learner will implement toward identifying or addressing health care disparities in his/her institutional learning environment; and,
- Define health care disparities in the context of the learner's patient population and articulate the process of setting measurable goals to minimize or eliminate disparities.

Baretta R. Casey, MD, MPH is the ACGME Regional Vice President, CLER Site Visit Program. She has served on the Boards of the ACGME and NRMP and on the AMA Council of Medical Education. At the University of Kentucky, she served as a Family Medicine Residency Program Director and Director for the Center for Excellence in Rural Health. Dr. Casey received the Distinguished Service Award from the Kentucky Medical Association.

John (Jack) O'Handley, MD is the Medical Director of Community Outreach at the Mount Carmel Health System in Columbus, Ohio, where he precepts residents and medical students on the Outreach Mobile Clinic and works with the Mount Carmel Street Medicine Program. Dr. O'Handley was honored as the 2017 Family Medicine Educator of the Year by the Ohio Academy of Family Physicians and received the 2015 Distinguished Educator Award from The Ohio State University College of Medicine.

Wilhelmine Wiese-Rometsch, MD, FACP is the Founding Program Director & Professor of Clinical Medicine at Florida State University Internal Medicine Residency Program at Sarasota Memorial Hospital, where the program earned the "2018 Sarasota Unity Award for Healthcare." She previously served as the Internal Medicine Residency Program Director for the Detroit Medical Center (DMC)/Wayne State University (WSU), Assistant Dean for GME at WSU, and Designated Institutional Official and Corporate Vice-President of Academic Affairs at DMC.
